Classes and stage presentations eligible for Continuing Education Hours (CEUs) will be designated with a CE banner. Look for this banner to easily identify which classes to attend.

No credit will be given for digital library courses. Only courses marked with  on 10/19 qualify.

Please carefully read the following information as it pertains to your state and license type.

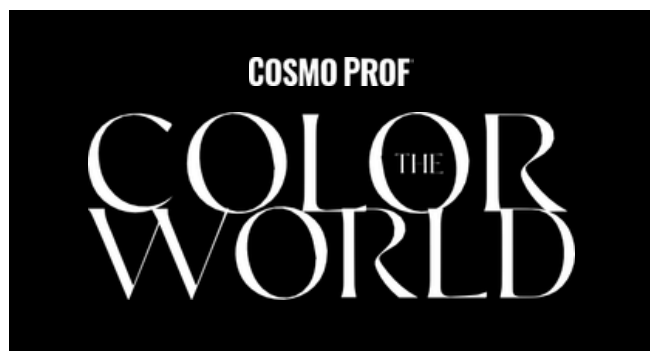

#### How To Earn Up To 6 CE Hours

Each individual CE eligible class is ONE CE HR. :

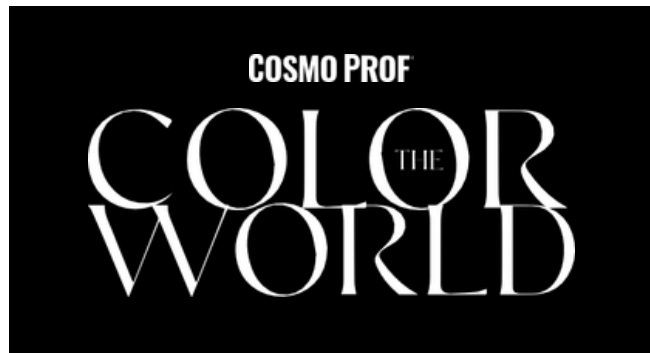
- Attend The MasterClass, Each Premiere Main stage Class (3 Classes), one CE hour earned for each CE class completed
- Attend one CE eligible class in each of our three classroom blocks (3 total classes, choose one class per classroom block, each class equals one CE Hour)



## GENERAL INFORMATION AND GUIDELINES

To obtain CEU Hours, attendees must:

1. Select your CE State during registration
    - Must provide full license # INCLUDING any prefix/suffix
    - Registration in advance required for ALL ELIGIBLE STATES.
    - **IL, NC, CO - Please see your state below for additional steps and details.**
  2. Each class is 60 minutes. Attend the full 60 minutes of each class you would like to receive credit for.
    - Late arrivals and connectivity issues are not exempt.
    - Must stay logged in and active during the class
    - Log in to only one class at a time with your unique log in.
    - If logged in to multiple classes/multiple devices, all classes during that time will be void.
  3. For each class completed a certificate will be sent Friday, 10/23/26
- Licensee will only receive hours for programs that contribute directly to the competency of their license as specified by your state's regulatory board.
- Supported license types and applicable classes:
- Cosmetology, general or advanced
  - Students, Apprentices, and Barbers are welcome to attend any class/stage presentation but do not need to sign up for credit and will not receive a certificate as CEU accreditations do not apply to these license types.

## **ADDITIONAL STATE DETAILS**

### **CEU CREDIT GUIDELINES - STATE SPECIFIC ILLINOIS**

Licensee will only receive hours for programs that contribute directly to the competency of their license as specified by your state's regulatory board.

Supported license types and applicable classes:

- Cosmetology
- Students, Apprentices, and Barbers are welcome to attend any class/stage presentation but do not need to sign up for credit and will not receive a certificate as CEU accreditations do not apply to these license types.
- Classes are considered in-person hours

To obtain CEU Hours, attendees must:

1. Complete registration for CE Hours in advance (required).
2. Must provide full license # INCLUDING the prefix
3. Attend the full 60 minutes of each class you would like to receive credit for.
  - Late arrivals and connectivity issues are not exempt.
  - Must stay logged in and active during the class
  - Log in to only one class at a time. If logged in to multiple classes, all classes during that time will be void.
4. For each class completed a certificate will be sent Friday, October 23rd by the end of the day.



## **ADDITIONAL STATE DETAILS**

### **NORTH CAROLINA**

CEU providers no longer report CEU hours or attendance to the State Board. It is the responsibility of the licensee to maintain records of attendance including:

1. Course title and description,
  2. Date conducted,
  3. Address of location where the course was conducted,
  4. Hours earned.
- CEU Certificates inclusive of the required information will be provided at the conclusion of each class as long as the attendee has followed the above general guidelines.
  - Audits of the licensee's continuing education may be conducted at any time. Upon the board's request, each licensee shall provide completed records to the board.

## **COLORADO**

Colorado does not require continuing education for license renewal.

- Education may be requested by the Board for license reinstatement if a license has lapsed.
- Classes may be used as supporting documentation for reinstatement, subject to Board review and approval.
- Course completion does not guarantee reinstatement.
